Violations Comments

Violation #52. Sewage & waste water properly disposed
Mop sewage was found to be disposed of outside of back door onto concrete, and grass/dirt. Mop sewage must be disposed of properly into mop sink or curbed drain. There is a mop sink present near kitchen.
CODE REFERENCE: 64E-11.003(5)(b). Sewage and waste water disposal shall comply with the provisions of Chapter 64E-6 or 62-600, FAC.

Violation #56. Ventilation & lighting
Ventilation in employee bathroom is not working. This must be fixed.
CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
